THIS NOTICE REQUIRES YOUR IMMEDIATE ATTENTION

We refer to the Aircraft Lease Agreement between GENERAL ELECTRIC CAPITAL CORPORATION ("Lessor") and DUTCH CARIBBEAN AIRLINE N.V.
