CONSIGNMENT AGREEMENT

This Consignment Agreement (this "Agreement") is dated as of April _____, 2009, by and between Wells Fargo Bank Northwest, National Association, a national banking association, in its capacity as owner trustee under the Trust Agreement (N416CA) dated as of July 31, 2007, whose registered office is at 299 South Main Street, MAC U1228-120, Salt Lake City, UT 84111 USA ("Consignor") and GA Telesis, LLC, a Delaware limited liability company with its principal place of business located at 5400 NW 35th Ave, Building 16, Fort Lauderdale, FL 33309 USA ("Consignee").

BACKGROUND

Consignor is the owner of the aircraft and engines specified on Schedule A (collectively, the "Consigned Goods", and where applicable, the "Aircraft", "Airframe", "Engines" or "Parts").

Consignee is in the business of marketing aircraft, aircraft engines, aircraft parts, components, and material substantially similar to the Consigned Goods, and Consignor would like to engage Consignee to market for lease, sale or exchange, and to manage and repair the Consigned Goods in accordance with the terms and conditions of this Agreement.

AGREEMENT

A. Engagement; Sales.

- 1. <u>Sales</u>. Consignor hereby engages Consignee on an exclusive basis to receive, maintain in inventory, market and sell the Consigned Goods in accordance with the terms and conditions of this Agreement. Consignee hereby accepts such engagement and agrees to use its commercially reasonable best efforts in its performance hereunder, including the sale of the Consigned Goods at then current market terms and conditions. All Consigned Goods leased, sold or exchanged by Consignee under this Agreement shall be referred to as "Sold Goods" and the parties acquiring Sold Goods shall be referred to as "Customers."
- 2. <u>Aircraft Recovery</u>. Consignee shall at the request of the Consignor manage the recovery of the Aircraft on behalf of the Consignor at Consignor's sole cost and expense ("Recovery"). However, Consignee shall pay up front costs related to the Recovery and such costs shall be reimbursed by Consignor to Consignee upon Consignee's invoicing of same. Recovery shall include, but not be limited to physical inspection of the Aircraft and the Aircraft records, arrangement of the ferry flight including flight crew and flight planning to the Delivery Location.
- 3. <u>Delivery</u>. Consignee will take possession of Consigned Goods at Opa-Locka International Airport, Miami, Florida (the "Delivery Location") on one or more dates specified in Schedule A (each a "Delivery Date"). If the Delivery Location is other than
